



Pike's Pit Bar-B-Que Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to Springbrook Business Park II and EWSN Investment, Inc. and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to EWSN Investment, Inc include Springbrook Business Park II and Pike's Pit Bar-B-Que. The Pike's Pit Bar-B-Que website is a News, Information, Online Orders site. By using the Pike's Pit Bar-B-Que website, you consent to the data practices described in this statement.

Collection of your Personal Information

In order to better provide you with products and services offered on our Site, Pike's Pit Bar-B-Que may collect personally identifiable information, such as your:

- First and Last Name
- E-mail Address
- Phone Number

If you purchase Pike's Pit Bar-B-Que's products and services, we collect billing and credit card information. This information is used to complete the purchase transaction.

We do not collect any personal information about you unless you voluntarily provide it to us.
